Re: 7-12 AIS Math Position

After careful review of recent NYS Math Test Scores, Grade Reports and Aims Web scores; we recognize the need for an additional Secondary Math Teacher to fulfill primarily AIS instruction at the Middle School level. Currently the Middle School has only one period of AIS Math being offered by a certified math instructor. Other periods are being covered by Special Education instructors. With the increased rigor of the Common Core Math standards, the need for a certified Math instructor is glaringly evident. The National Council of Teachers of Mathematics and the What Works Clearinghouse report that explicit and systematic instructional methods are highly effective intervention strategies for at risk students. The expertise of a certified math teacher is recommended to deliver this instruction. We are respectfully requesting the addition of a 7-12 certified Math Teacher to provide this necessary support for our students.
