Dear Board of Education Members:

I offer this letter as my formal announcement of my retirement from my position as a fourth grade teacher in the Attica Central School District. My retirement will be effective as of June 30th, 2017.

I will not continue health insurance coverage in retirement through the District. I understand that I will be entitled to credit for my unused sick leave that I have with the District at the time of my retirement. I am opting for \$40 per day credit to be in a "cash" payment and not applied toward health insurance. I am also claiming other benefits to which I am contractually entitled. This is the first year I am eligible to retire without penalty. I will be 62 with 24 years of service with Attica Central School District and a total of 25 years with the state of New York. I will be eligible to receive through the District the incentive of \$16,500. The additional \$1,000 bonus incentive with my notification before December 31st prior to my June 30, 2017 retirement is also due.

I would like to express my gratitude for a rewarding professional experience during my employment with the District. I will surely miss the students and staff I have had the pleasure of working with over the years.
